- Must have closed one or more transactions during the 2018 calendar year.
- Must register to attend the 2019 IBBA Annual Conference in Orlando, FL by February 28, 2019.
- Must enter on or before February 28, 2019 and follow the entry steps on the next page of this brochure.

Persons not meeting these requirements, or who submit late or incomplete documentation, will not qualify.
