CBI EXAM INSTRUCTIONS AND TERMS:

CBI applicant is responsible for finding three (3) potential test proctoring sites. IBBA staff will schedule the exam to be taken at one of the locations provided by the applicant. Most locations charge a proctoring fee, which will need to be paid by the applicant at the location the day of the exam. Some locations charge this fee in advance. Cost varies based on the location, ranging from \$50.00-\$150.00 USD.

Please list three (3) testing locations in your area below in order of preference. IBBA staff will ensure the chosen location has proper proctoring procedures and will coordinate delivery of exam and all necessary materials.
